	Stage 2 - Detailed Survey A member of the Environment Agency and the appointed specialist contractor will attend each individual property to undertake a detailed survey. The contractor will determine the build type of the property and recommend the most suitable bespoke PFR measures to be implemented. The recommendations will be fully explained during this survey and any questions can be asked to ensure the homeowner is fully understanding of the proposal.	
	Stage 3 - Homeowner Agreement The formal recommendations will be placed into a homeowner agreement where the homeowner will be given a period of time

	to review the measures and decide if they would like to proceed. Any recommendations over the £7500 limit will be made clear to the homeowner and informed of the contribution top-up required.	
	Please note the £7500 limit is enough to fully protect an average sized home. If they are happy they will be required to sign and date the	
	agreement at which point the contractor will be able to formally place an order for manufacture. The contractor will then arrange a suitable date for installation convenient for both parties.	
	Stage 4 - Installation · Measures will be custom made to order and brought to site by the contractor.	
	 Specialist installers will fit each measure over the course of 1-2 days. A formal handover will be provided with the homeowner where 	
	deployment instructions and product explanation will be undertaken. A handover pack will also be provided.	
	Stage 5 - Post-Installation Within 12 months of installation a mock flood exercise will be held for homeowners to practice their full deployment
