## Capel Neighbourhood Plan – project plan Dec 2021 to Dec 2022

The Government has allocated over £30m between 2018 -2022 to support the development of neighbourhood plans or neighbourhood development orders. You can apply for grant funding and/or technical support if you are eligible.
